## **Assistant Regional Harbour Master Gladstone**

Maritime Safety Queensland (MSQ) is seeking applications from suitable candidates for the position of Assistant Regional Harbour Master (ARHM) to cover the Gladstone region. This contract will be offered for a period of three years, with the possibility of extension.

This role reports to the Regional Harbour Master (RHM) of the Region and you will be a key member of the regional management team. The role is also required to provide support to the Executive Director (Port Operations and Vessel Traffic Services) as directed in the management of the delivery of Pilotage Regulation throughout the State. Additionally, the role supports the Executive Director and the RHM in the preparedness, coordination and the delivery of the National Plan for Oil Spill Response and will act, as required, as the designated Incident Controller within designated Regions.

This is a maritime specialist position which requires the successful applicant to have a high level of knowledge, expertise and understanding of maritime safety matters and industry developments at a national and international level. The role has significant deliverables and accountabilities that directly impact the maritime industry and sector in the designated region.

### **The following qualifications / requirements are mandatory for this position:**

- Certificate of Competency as Master (Unrestricted) or the equivalent Certificate issued or recognised by the Australian Maritime Safety Authority.
- Other educational or sea-going qualifications or experience acceptable to the Director-General.
